### LETTER FROM THE PRESIDENT

Education at Elevation (E@E) celebrated its fifth year and we couldn't have done it without you. This past fiscal year June 2011 – July 2012 we transformed our brand with a new name, logo, and website. But the biggest and far greatest news is about the students at Nga Gyur Shep Dup Cho Ling School.

#### The students are thriving!

This past year the school was honored to have a guest teacher, a specialist in Tibetan writing, visit for several months. The Tibetan writing instructor made a huge improvement in the children's education by expanding their knowledge of the Tibetan language.

According to Sonam Rinpoche, the school founder, **writing** is a special skill that is difficult to acquire in a culture that is traditionally nomadic. Many Tibetans know how to read the Tibetan texts, but they do not know how to write in Tibetan. Because of the dedicated instruction this teacher provided, the children now have a comprehensive knowledge of their native language.

Today there are 75 boys and girls in the Anzi village who know how to read and write in both Tibetan and Mandarin (the official language of China). This amazing accomplishment has been made possible because of your generous support. Your support catapulted **the literacy rate from less than 2% to 25%** in this tiny little village in Eastern Tibet.

### Water Project Update

The water project data collection has been underway since October 2012 and will be complete by the summer of 2013. The water project construction will begin the summer after engineering design has been finalized by Living Earth Institute (LEI). LEI is a Seattle-based non-profit that specializes in building water and sanitation systems in developing communities. We are very thankful to have them working with us on this project and look forward creating a much-needed sustainable water system for the school.

## Who, What, Where, When, and How

**Mission:** To provide a home and educational opportunity for unfortunate Tibetan children in Garze Tibetan Autonomous Prefecture, China.


#### Our goals:

- To support orphans and poor children at the school "Nga Gyur Shed Dup Cho Ling" (loosely translated to The Early Translated Dharma Teaching and Study Center), located at a rural village in Garze Tibetan Autonomous Prefecture, Eastern Tibet
- To provide an education, housing, clothing, basic living items for the children and staff at the 'Nga Gyur Shed Dup Cho Ling' School.





## **Program Services**



All of the students can now read and write Tibetan. This is a great accomplishment. The literacy rate jumped *from* 2 to 25% in this remote nomadic village. The boys and girls continue to study Tibetan along with Mandarin and mathematics.

The school now has five teachers: two for introductory Tibetan, two for advanced Tibetan, and a female teacher for the girls. The teaching staff has *increased by 66%*, from three to five teachers this year.

Mandarin teachers are also hired or volunteer for several months at a time.





### ${\mathcal T}$ he students usually take

their tests in December of each year to evaluate their progress. Last year, five male students scored excellent in their tests. Three out of 10 female students are also doing really well.

Because of the Tibetan culture, girls traditionally do not receive an education and it has been a challenge to encourage girls to enroll. Our goal for 2013 is to increase the female enrollment.





## **Program Services**

### Food Supply



*E@E* provides most of the food supply for the students and teachers. This year food prices have stabilized compared to a 20% annual rise over the last two years. The food sent to the school consists of rice, dried noddles, pork, potatoes, flour, and vegetables (baby bok choy).



Vegetables and pork are rare treat for the children.



## **Program Services**

### Cast Iron Stoves

Were replaced this year. The stoves are used daily and provide the only source of heating and cooking.

The stove offers warmth and comfort every day and will last for years.





